#### **COURSE HIGHLIGHTS**

#### **Fundamentals of Taxation**

This course introduces students to the role of taxes in contemporary society and their impact on individuals and business entities with emphasis on Federal income taxation.

## **Auditing Theory and Practice**

The course covers principles and procedures applied by independent auditors and internal auditors, responsibilities of auditors, development of audit programs, accumulation of evidence, and statistical and EDP auditing applications and reporting.

#### Investments

The topics covered in the course include financial markets, securities trading, evaluation of the risk/return trade-off, efficient portfolio formation, fixed income security valuation and interest rate risk, and an introduction to derivative securities.

Accounting and financial professionals are involved in several aspects of a company's operations in a rapidly changing marketplace. Accountant employment is expected to grow 10% from 2016 to 2026, while employment of financial analysts is estimated to grow 11% during the same time period. Both rates are faster than the average for all occupations, indicating strong employer demand for both professions.
